SOP: Disinfection and Cleaning Protocols

This SOP defines **disinfection and cleaning protocols** to maintain hygiene and prevent contamination in the workplace. It covers the selection of cleaning agents, proper cleaning techniques, frequency of cleaning, disinfection procedures for surfaces and equipment, personal protective equipment (PPE) requirements, waste disposal methods, and verification of cleanliness. The goal is to ensure a safe and sanitary environment by minimizing the risk of infection and cross-contamination through standardized cleaning practices.

1. Purpose

To establish standardized procedures for the effective cleaning and disinfection of the workplace to prevent contamination and ensure safety.

2. Scope

General floors and corridors	Daily

8. Disinfection Procedures

- 1. Apply disinfectant to surfaces following manufacturer instructions (contact time, dilution, etc.).
- 2. Allow surfaces to air dry completely or wipe with a clean cloth, as specified.
- 3. Pay special attention to high-risk and high-touch areas.

9. Waste Disposal

- Dispose of cleaning materials and PPE in designated bins.
- Segregate hazardous waste and follow local regulations for disposal.
