SOP Template: Infection Control and Hygiene Measures During Transport

This SOP details **infection control and hygiene measures during transport**, including vehicle sanitation protocols, personal protective equipment usage, hand hygiene practices, waste management, and disinfection procedures. The aim is to prevent the spread of infectious agents, ensure the safety of personnel and transported goods, and maintain compliance with health regulations throughout the transportation process.

1. Purpose

To establish standardized infection control and hygiene procedures during transport, to minimize cross-contamination, and to comply with health and safety regulations.

2. Scope

This SOP applies to all personnel involved in the transportation of goods, samples, or individuals under conditions where infection control is required.

3. Responsibilities

- Label and dispose of waste in accordance with institutional and local regulations.
- Thoroughly clean waste collection containers after use.

8. Disinfection Procedures

- Disinfect all surfaces, equipment, and materials used during transport as per manufacturer and safety guidelines.
- Allow sufficient contact time for disinfectants to be effective.
- · Ventilate vehicles adequately during and after cleaning to reduce inhalation risks.

9. Documentation and Record-Keeping

- Log all cleaning, disinfection, and waste disposal activities.
- Report any incidents, exposure, or breaches in protocol to the supervisor immediately.

10. Training
