SOP Template: Daily and Periodic Deep-Cleaning Schedules

This SOP details the **daily and periodic deep-cleaning schedules** necessary for maintaining optimal hygiene and cleanliness standards. It covers routine cleaning tasks, designated cleaning frequencies, proper use of cleaning agents and equipment, and specific deep-cleaning procedures to prevent contamination, ensure safety, and promote a sanitary environment. The schedule aims to support operational efficiency and compliance with health regulations.

1. Purpose

To establish consistent cleaning practices that maintain hygiene, prevent contamination, and comply with regulatory standards.

2. Scope

Windows & Glass	Spot-clean fingerprints	Wash thoroughly, inside and out	Deep clean: Every 2 months

5. Cleaning Agents and Equipment

- Use only approved, labeled cleaning agents compatible with the items being cleaned.
- Utilize appropriate PPE (gloves, masks, goggles) when handling chemicals.
- Maintain and clean all mops, cloths, and equipment after each use to prevent cross-contamination.

6. Deep-Cleaning Procedures

- 1. Clear the area of all removable items and waste.
- 2. Apply prescribed deep-cleaning agent as per manufacturer instructions.
- 3. Allow appropriate contact time for disinfectants.
- 4. Scrub surfaces with designated tools.
- 5. Rinse (if necessary) and dry all surfaces thoroughly.
